Hello! This is Takako Shimatani. I received a lot of feedbacks as below; 'Your articles about handguards are excellent. They are very interesting, 'Your explanation about hanguards is easy for me to understand.' So, I am likely to talk about 'Mino handguard' in this article.



After nin War (1467-1477), the Uchigatana sword became popular. Because of this trend, demands for a mounting of sword were high. Mino where the handguard was born was an important point for traffic and near to Kyoto where chasing techniques had been developed in Heian Era. So, sword smiths, armourers, scraped- iron smiths and so on used their skills to produce metal parts of swords and armours. These professionals used red copper (inclusion of copper, gold, tin and lead) and Yamagane (unrefined copper with blue colour) which were softer and easier to fabricate and produced equipments attached to swords. Mino handguards were divided to two types: Ko-Mino (what were created before Azuchi Momoyama period) and Mino(what were created after Azuchi Momoyama period)

Characteristics⁶


Mino(Gifu prefecture) was flourished as a place of making swords. So, it became very popular as a place to create attachments of swords as well. (Minoden: Feb.2016 Vol10)

- ·Surface was blacker than Mino
- · Carving is not round and the lines of carving were sharp. Ko-Min



The carving techniques which were able to be made only in Mino. The unimaginable long works which were made by wholly hands in spite of no equipments, machines, etc like the modern society. The fine carving and real minute craftsmanship stunned me. No same things. Each attachment to swords had a different face and shape. I liked simple iron handguards produced by swordsmiths and armourers. But Mino-handauard, what creators carved and shaped little by little cautiously, also fascinated me.

I had a discussion with Mr. Robert Ken.

In the first place, why was Ryoma, who had left his master's domain and became a masterless Samurai, able to meet important persons of other Domains and Edo Shogunate, in spite of the strict class system in Edo Era? Because Ryoma was a local staff of arms delaer. Don't you think so?

'Ryoma was an arms dealer....To be sure. I have an image that he had a pistol.'

But, while Ryoma was engaging in that job, he was capable of grasping what the European Powers designed secretly and thought Japan would have been colonized by them. I suppose Ryoma might feel sense of danger. Naturally, Britain treated Ryoma who had changed side and had no worth supporting for Britain as an obstacle.

Many parties who had different intentions shared common interests directly or indirectly and assassinated Ryoma-I guess. What Ryoma did not expected was that Ryoma never imagined Ryoma was killed by the members of his group.



Ryoma thought of Japan in the future and became an arms dealer. But Ryoma got the bid of European Powers to colonise Japan and made efforts to avoid civil wars in Japan. I thought as above, too. But, a civil wan had been occurred finally after Ryoma's death.....In the political confusion. I think the heroes who rendered distinguished services in Meiji Restoration and made big development after Meiji Restoration were excellent. But, I cannot ignore the contribution by Ryoma who foresaw the future prior to these heroes and made actions! Ryoma, a Samurai who left Tosa and thought of Japan, was killed by the feudal retainers of the Tosa domain..... His sad last moment

Disapointed!

I had a discussion with Mr. Futen no Mabo:

When I read various kinds

- of books about Ryoma, they have the four points in common.
- Two Samurai warriors with having a business card of kizugawa feudal retainers were permitted to go to the 2nd floor. They were assassins.
- 2) From the entrance of 1st floor, one assassin entered the room and killed a male servant first of all.
- 3) Ryoma had no time to draw his sword and was slashed.
- Nakaoka who was there with Ryoma was cut to pieces, but he had been still alive for a couple of days.

When I treated these things as what were connected, I can imagine as below;



These four things are always mentioned,

At first, two Samurai warriors with having a business card of Kizugawa feudal retainers were permitted to go to the 2nd floor and started to talk with Ryoma and his group members. Other associating members knocked the door and began to attack the male servant who responded to them! The assassinator killed the male servant who was likely to tell Ryoma about the danger from his behind in a single stroke.

If it had been true. I feel Ryoma, who was killed by the believed members of his group, regretful

Ryoma noticed some big noise on the 1st floor and was going to stand up with saying 'do not be noisy!' . Ryoma distracted his attention to other assassin in front of Ryoma. At that moment, the killer in front of Ryoma drew his short sword and in the same stroke, cut down Ryoma. I think the assassinator maybe aimed at Ryoma's neck. But. since Ryoma made his head down. Ryoma got an injury in his forehead and was about to take his sword. Then, Ryoma received a stroke of sword on his back when Ryoma looked back. It is my assumption.

'So, he had a big wound! But whey did the killer use a short sword?'

The reason why I thought the killer used a short sword was that the assassinator generally held a long sword on his right side and it was very difficult for him to draw a long sword. And I can also imagine the reason from the fact that Nakaoka had been still alive for a couple of days even though he got a serious wound.

'A short sword was unable to make a serious injury. Because of it, Ryoma did not die immediate

The other reason was some difficulties to swing a long sword in a room under a low ceiling. And the purpose of assassinate group was to stop moving Ryoma for a few months, even though they were unable to kill him. For them, it was enough. After the assassinators had left the site, Ryoma and Nakaoka were said to exchange a couple of words, which means they did not put an end Ryoma's life. Ryoma's failure to make action for a couple of months would enable to start a civil war.—I thought....

> Was it a direction from Satsuma and Choshu domains to overthrow the Shogunate using armed forces?'

I learnt the swordsmanship called Sinto Munen Ryu. My hypothermia as above comes from the study of swordsmanship, which taught me the choice of sword depends on places and purposes when using swords, after learning this swordsmanship.

'Mr./Mrs.. Futen no Mabo studied the swordsmanship. So, only you can make the special analysis.

The reasons why the assassinators used a short sword were that their purpose to attack Ryoma was to wound Ryoma only as well as they charged Ryoma indoors!!!. That is an excellent guess!! While the injury of Ryoma's forehead was said to be the fatal wound definitely, Ryoma was not finished off. Nakaoka had been alive for a couple of days. Because Mr./Mrs.. Futen no Mabo made an analysis from the viewpoint of swordsmanship, it gave me presence and very interesting. Your opinion tells me that this accident had been completed within only a few minutes. Though

Mr./Mrs.. Futen no Mabo also send me his long description about 'Three Stage Thrust by Koji Okita, a leader of Shinsengumi', I would leave it out for want of space. I am very sorry. If I have another chance. I will show your assumption in our newsletters.
